## II. CONFESS UNFORGIVEN SINS

1. It is to be a continual confession:  
Present tense verb..."say the same thing, agree with God." Can two walk together except they be agreed.

\*We develop a sensitivity to sin, the moment we become aware we confess it, continue to walk in the light, receiving fresh supplies of grace.

2. It is to be a complete confession "SINS"  
The plural indicates a specific, one-by-one confession. Name them one by one, just like we do our blessings.

3. It is to be a confident confession.

(1) Faithful--to His promise to forgive.  
God will keep His word.

(2) Just--"Righteous"...in that He won't demand payment twice. Jesus has already paid for it all...2 Jon. 2:2

(3) Forgive: remove the sin — *takes away guilt*  
cleasne: remove the stain — *Take away pollution*  
*NO need to feel dirty*

Forgive: has to do with our record.  
Cleanse: has to do with our character

Kim sick - many just things a parent learns  
is how to handle enemies, health & growth  
= Some spectrally = Sin.
